Article II, Section 1. Eligibility, General membership is open to any persons who subscribe to the objective of this club, agrees to abide by its' Policies and Procedures and Bylaws, and is interested in the sport of agility. Members under the age of eighteen years of age must be accompanied at all times by a member of their household over eighteen years of age.

Article II, Section 3. Election of Active Membership, The proposed applicant shall submit dues payment for the current year, and an application fee... The applicant shall be asked to attend 2 regular meetings, after receipt of their application. Their name shall be read at both meetings and shall be included in the minutes of the meetings. At the third meeting, the application will be voted upon. The club shall elect such applicant by a favorable vote of 75% of the members present. Lastly, per Kruisin' Kanines Policies and Procedures Book, all three meetings shall be attended within six months of the date of this application.
