MEMBERSHIP APPLICATION AND PROCEDURES

Membership Application Procedures:

1. Obtain a Membership Application from the box on the table in the training facility; request an application from the Membership Committee Chair (Peg Antrobus); from any instructor; or from the website on the home page, event page, or the class registration page.
2. Complete the Membership Application and obtain two sponsor signatures. Any Kruisin' Member can sign as a sponsor, but they must be willing to attend the meeting when your application is read, and speak for you.
3. Present or mail your completed membership application (including sponsor signatures) and your remittance check to Peg Antrobus.
4. Upon receipt of your completed application and check, your application will be read to the Kruisin Kanines membership at the next Membership meeting. One or both of your sponsors must attend this meeting to support your application for membership, but you will not attend this meeting. A 2/3 majority of members present at the meeting is needed for approval.

When your application has been approved, the Membership Committee Chair will notify you, and you are considered an Active Member for that six month period. You will be presented with a club shirt.

In order to remain an Active Member, you must:

- Pay applicable yearly membership dues.
- Not be in debt to the club. Dues and training fees are considered a debt.
- Attend at least two General Membership Meetings in each half of each year (January- June, July to December).

2. Voting privileges on club matters
3. Ability to attend classes and training sessions at reduced rates
4. Training facility reservation privileges
